citizen yourself and there is not a situation where the voting rolls are somehow transferred over and people start investigating, etc."

In 2013, Governor Jerry Brown of California signed a bill (known as Bill AB 60) removing the proof of legal residence to obtain a state-issued driver's licenses.

In California, you only need a driver's license, as identification, in order to register to vote. *(More recently a bill was passed that automatically registered to vote any person with a driver's license; AB 60 licenses were not exempted.)*

**About AB 60**

- Governor Jerry Brown signed **Assembly Bill 60, The Safe and Responsible Drivers Act** in October, 2013 and the bill became law on January 1, 2015.
- Under this new law, any eligible California resident will be able to apply for a driver's license, regardless of immigration status.
- An AB 60 license will have a visible distinguishing feature and cannot be used for certain federal purposes, such as to accessing restricted areas of federal facilities.
- Driver licenses do not give California residents the right to work or vote and it does not make them eligible for any benefits that they were not eligible for without the license.

**Over 1,000,000 have been issued.**

While the regulation states clearly that AB 60 driver's license cannot be used to vote, as of April, 2018 California law automatically registers to vote anyone with a driver's license; AB60 licenses were not exempted.

The assumption that they allowed this opportunity for illegal voting is supported by their refusal to allow the federal government to audit their voting records.

People also vote multiple times.



Rosa Ortega registered to vote in five different cities in Texas, even though she's not a citizen. She voted all five times for Hillary and then said she wasn't aware she'd done anything wrong.

I'm not surprised, Obama essentially told them that there wouldn't be a penalty for voting illegally.

In early 2015, The Pennsylvania Secretary of Commonwealth stated that around 731 people may have double voted in Pennsylvania.

We will probably never know how many dead people vote, because democrat states don't clean their voter files and refuse to be audited. But, there are numerous instances, for example, Sara Sosa, a woman who died in 2009, voted in 2010, 2011, 2012, and 2013.

Personally, I estimate that the democrats received between and 8 and 10 million illegal votes in November, 2020.


